## PROCEEDINGS OF THE GOVERNMENT OF KARNATAKA

Grant of No Objection Certificate for establishment of Nagambika College of Education for Women, Gulbarga for the academic year 2006-07.

## PREAMBLE:

- 1) The State Government has lifted the ban on the issue of No Objection Certificates for establishment of B.Ed. / B.P.Ed. Colleges in all mediums of instruction from the academic year 2003-04 in G.O. dated: 29-04-2003. In G.O. dated: 02-06-2003, the Universities were directed to advertise calling for applications for establishment of B.Ed./B.P.Ed. colleges for the academic year 2003-04 and to process the applications by following the procedures prescribed in Section 59 of the KSU Act, 2000 and thereafter to submit them to Government to enable it to consider for grant of NOCs under regulations 5 (e) of the NCTE Regulations, 1995. It was clearly stipulated that while processing these applications, the norms and standards prescribed by the NCTE should be followed scrupulously. After completing the process, the Universities have submitted the proposals to the Government along with necessary documents.
- 2) Government have examined the proposals received from the Universities keeping in view of the number of existing B.Ed./B.P.Ed. Colleges, their regional distribution / imbalance, the prolonged ban on the establishment of Teacher Training Institutions in the State, the demand for admission to B.Ed./B.P.Ed. Courses, the employment opportunities and also the future requirement of teachers in higher primary and higher secondary education sectors and various other factors incidental for taking a decision to grant No Objection Certificates for establishment of B.Ed./B.P.Ed. Colleges in the state.

- 3) The Karnataka State Women's University has been established at Bijapur in the academic year 2003-04. The Karnataka State Women's University, Bijapur had called for the applications to start Women's B.Ed./B.P.Ed. Colleges. The Karnataka State Women's University, Bijapur after processing the application Under Section 59 of the KSU Act, 2000 has submitted the proposal to the Government along with necessary documents for grant of NOC for the establishment of Nagambika College of Education for Women in Gulbarga, for the academic year 2006-07.
- 4) The State Government has examined the matter and decided to grant NOC to Nagambika Educational and Charitable Trust, Vittal Nagar, Gulbarga for establishment of Nagambika College of Education for Women, Gulbarga.
  - 5) Hence the following order.

- 6) In the circumstances, Government of Karnataka are pleased to grant issue of **No Objection Certificate** to Nagambika Educational and Charitable Trust, Gulbarga for establishment of **Nagambika College of Education for Women, Gulbarga**, for offering B.Ed. course with an intake of 100 from the academic year **2006-2007** under Regulation 5(e) of the NCTE Regulations, 1995, subject to the following conditions:-
  - (1) No grant-in-aid shall be sought from the Government for running the proposed college; it shall be subject to **permanently unaided** policy of the State Government. The institution shall give an undertaking to Government to this effect at the time of sanctioning affiliation based on the recognition to be granted by the NCTE SRC.

(2) The institution shall provide adequate infrastructure, staff etc., as per the norms and standards prescribed by the National Council for Teachers Education and also the affiliating University;

(3) The institution shall abide by the orders of the State Government and the statutes and regulations of the affiliating University issued from time to time with regard to admission policy and recruitment of staff to the institution etc;

(4) The institution shall collect 'Tuition fee' and 'Other fees' as prescribed by the State Government from time to time. The amount collected shall be utilized by the institution in accordance with rules;

(5) The management should start the institution only after obtaining recognition from the National Council for Teacher Education, Under Section 14 of the NCTE Act, 1993;

(6) The conditions stipulated in the LIC report shall also be adhered to by the said College.
